

ORDINANCE No. 2013-06

An Ordinance setting rates and fees for activities under the supervision of the Fort Payne Parks and Recreation Department.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL AS THE GOVERNING BODY OF THE CITY OF FORT PAYNE, ALABAMA AS FOLLOWS:

- **SECTION 1.** That Ordinance No. 2013-04, adopted by the City Council on March 19, 2013 is hereby rescinded and repealed in its entirety.
- SECTION 2. That any person, group, agency, or corporation wishing to use the facilities or properties of the Fort Payne Parks and Recreation Department or participate in any Fort Payne Parks and Recreation Department sponsored activity shall pay the appropriate fees to the City of Fort Payne, and shall conform to the regulations as herein stated.

SECTION 3. **Definitions:**

- a) Dependent Children: Children living at home under the age of 23 and attending school.
- b) Family: Consist of two (2) parents and up to two (2) dependent children, or one (1) parent and three (3) dependent children.
- c) Senior: A single individual age 65 and over
- d) Senior Couple: Two persons married age 65 and over
- e) Super Senior: A single individual age 80 and over

Pool parties are scheduled from 6:00 p.m. - 8:00 p.m. Monday-Sunday)
